**DIRECTIONS FOR USE****PREPARATION**

Sweep or vacuum to remove loose materials from the surface to be cleaned. Pre-clean oil spots or other deep stains with the appropriate cleaner.

APPLICATION

Application Instructions Before use, read "Preparation" and "Safety Information." ALWAYS TEST for suitability, dilution rates and desired results before application. Test using the following application instructions. Let surface dry thoroughly before inspection. Equipment This product is specially concentrated for use with an automatic floor scrubber. Use soft brushes/soft pads. Never use aggressive brushes or pads on polished concrete. Dilution Dilute one 60ml PACKAGE per 25 liters of fresh water or add 60ml to the automatic floor scrubber water tank.

1. Apply with an automatic scrubber.
2. Routine Cleaning: Scrub the floor with squeegee down and vacuum/squeegee engaged. Remove cleaning residue. Deep Cleaning—Double scrub: Apply cleaner and scrub floor with brushes-pads engaged, but vacuum up. Allow product to dwell on surface without drying for 15 to 20 minutes, then scrub again with the brushes on and vacuum/squeegee engaged. Add more cleaner as necessary.
3. Buff the cleaned floor with a white pad to increase shine.

DILUTION / COVERAGE RATE

Dilute one 60ml PACKAGE per 25 liters of fresh water.

1. Apply with an automatic scrubber.
2. For routine cleaning, rinsing the concrete floor is not necessary. Vacuum up spent cleaner and dissolved contaminants with auto scrubber. For deep cleaning, or for cleaning in food- processing areas, rinse well with fresh water. Do not let puddles or concentrated cleaner dry on the floor. Vacuum up rinse water with automatic scrubber.
3. Buff the cleaned floor with a white pad to increase the shine. Clean tools and equipment using fresh water.

Pentra-Clean® (CR) is also available in concentrated pre-measured packages for 25 – 50 liters auto-scrubber tanks. Just add a 60 ml package per 25 L (add two 60ml packages of **Pentra-Clean® (CR)** for a 50 L auto scrubber tank of fresh water, and you're ready to clean. This specialized blend of degreasers and detergents removes most common soiling found on concrete floors daily. It is ideal for concrete floors everywhere, from warehouses and manufacturing plants to schools, stores, hospitals, restaurants and more.
